





Amberley Snyder Inspires Our Youth

Amberley would be arriving at any time. You could feel the anticipation in the air.

Four hundred people packed the AG "A" building at the Spokane Interstate Fairgrounds. Bryant Grentz, who does outside sales and deliveries for our Spokane area Country Stores, emceed the event. Bryant kicked off the evening by thanking everyone for attending and introduced Bailie Welton, our Community Outreach Coordinator/Marketing Assistant.

Bailie described the Country Stores' Youth Rewards Program, then introduced Gabrielle Sweetser, member of the Davenport FFA and grand prize winner of our 2018 Youth of the Year Essay Contest. She also introduced Emma Wilson from Colbert, Washington, member of the North Country 4-H, who won 2nd prize in the essay contest.

Next, Kate McKlosky, the WSU Spokane County Extension 4-H Coordinator, spoke about 4-H and how to get involved with local clubs. Kate, Bryant and Mike Miller from Purina drew raffle tickets for Purina prizes.

Then Bryant introduced our headliner, Amberley Snyder, and the crowd erupted in applause.

Amberley told an amazing story of her courageous journey from being on top of the world at 18 years old with an almost

unbelievable future ahead of her, to a near-death vehicle accident that left her paralyzed from the waist down. She told of her tenacious attitude and the three goals she set from her hospital bed, just days after the accident: walk, ride and rodeo.

Nothing stopped this girl! Within a few months, she was back in the saddle and, within eighteen months of her tragic accident, with a seatbelt on her saddle, she returned to rodeo competition.

Near the middle of her story, Amberley played a video of her early life from a toddler who loved horses to a young equestrian in a wheelchair. The story featured Amberley today competing in rodeo events and caring for her horses at home in the barn. There was not a dry eye in the building.

Amberley wrapped up her speech with questions from the audience. After the Q&A session, she invited the crowd up on stage for pictures.

I am so proud that Skagit Farmers Supply and the Country Stores could be part of such a wonderful, free event for our community.

Annual Meeting Atmosphere Optimistic

Skagit Farmers Supply wrapped up its 84th annual producer member meeting on March 14th in an optimistic atmosphere. Our strong results from fiscal 2017 were shared with the membership, and the 2007 stock retirement checks were handed out. Throughout 2017, we saw sales growth in energy, retail, wholesale and at our mill; and strong margins in 2017 overcame higher expenses to give the co-op a record year in earnings and patronage.

You should see some nice checks in the mail this summer as the board has approved 40% of our member earnings to be distributed in cash again this year. It pays to shop at your local co-op.

Despite some headwinds we're wrestling with—like tight labor markets, increased competition and softer margins—we're feeling quite confident at Skagit Farmers Supply. We're almost half way through the 2018 fiscal year, and we're either matching or exceeding those strong sales numbers from fiscal 2017.

We're also confident because we're on the right side of consumer trends. Our members are meeting consumer desire for fresh and healthy food. Despite the increased popularity of renewable energy sources, when major population bases on our

Attendance Up at Recertification

Attendance was up this year at the grower recertification meetings sponsored by Skagit Farmers Supply and held at McIntyre Hall on the campus of Skagit Valley College. We received positive feedback about the new location and the meeting content.

The February 20 meeting focused on production agriculture, and the February 21 meeting focused on greenhouse, ornamental, nursery, turf and vegetation management.

As always, growers who attended these meetings received credits toward the recertification of their Washington State Department of Agriculture applicator licenses.



Olympia Potato Day Meetings

Agronomist Charlie Anderson joined several producer-members of Skagit Farmers Supply in hosting senators and representatives at Olympia Potato Day Meetings January 30-31, 2018. "We served 1,600 baked potatoes with everything on them to folks in the capitol building, a time-honored and well-received tradition," says Charlie of the event sponsored by the Washington State Potato Commission.

Over the two-day event, potato commission teams met with and spoke to 45 senators and representatives, including Sen. Barbara Bailey, Rep. David Hayes, and Rep. Norma Smith from District 10.

Topics of conversation included the Potato Commission's position on the proposed SB 6529 Pesticide Application

Notification and Gov. Inslee's Carbon Tax.

"SB 6529 proposed legislation adds the Department of Health to the Department of Agriculture and Labor & Industries in regulating pesticide usage by our growers," says Charlie, who adds that this duplicate regulation is unnecessary. "The four-day prior notification requirement (in this proposed legislation) would make IPM practices untenable, forcing growers to actually spray more frequently on a prophylactic basis, likely resulting in more drift incidents which are illegal under current EPA regulation."

"Despite the cut-out exemption for farm and food processor use of fuels," Charlie says of the proposed carbon tax, "the expected \$.20 per gallon on-road fuel tax would indirectly increase cost in distribution channels for agricultural

finished goods and inputs such as fertilizer and chemicals." As a result, it is the Washington Potato Commission's position that, "Any or all of these cost increases imposed at a state level will cripple production agriculture's ability to compete in the low-margin global marketplace and should not be adopted."

Charlie added, "Potato Commission members really appreciated the support from Skagit Farmers Supply."

5th Annual Truckload Sale a Success

January 23rd marked the start of the 5th Annual Truckload Feed Sale for the Country Store retail locations. After the holidays wrap up, our feed mill and distribution warehouses turn up the heat by moving over 50 semi-truck loads of feed, bedding and product into our 13 Country Store locations as we gear up for this yearly event.

Months prior, our AFCO warehouse, our mill management, and our retail buying team start crunching numbers and strategizing on how to best execute the enormous task of moving over 1,000 tons of product out to the Country Stores. See the store list on page 6.

The event started to drive some volume business through January, which is traditionally a quiet, non-sales flyer month for the retail stores. The first Truckload Sale was a hit, and customers were calling for more. Five years later, we are going strong. We're pulling customers from as far as the Canadian border, south Lynnwood and everywhere in-between.

Skagit Farmers Supply LMF and AF feeds were the drivers of this year's event at hot prices that encouraged customers to purchase by the ton. The top-selling feed item was AF Egg Layer Pellets with over 3,400 bags sold in just six days.

Leading up to this event, we had some great pre-orders placed through our outside sales rep Bryant Grenz, based out of our Central Spokane location. These orders totaled over \$24,000. The bulk of these sales were bedding pellets (along with LMF feeds) to some large equestrian complexes in the Spokane area.

This event also opened some new customer business, with the assistance of Harris Statema, LMF Feeds, and Greg Senyitko from our Stanwood Store. Harris and Greg were able to put together a wonderful feed program for a large breeding facility outside of Stanwood. Working hand-in-hand with the farm's veterinary staff, they scheduled monthly deliveries of LMF feeds and bedding pellets.

So, not only has this event grown, but we've also been able to capture new customers who will continue to buy from us in the months and years to come.
